Market Guidelines

I. PARTICIPATION

- A. The Farmers' Market consists of growers in Allen County of vegetables, fruit, and other related agricultural and horticultural products; Kentucky producers of "added value" items such as baked goods, jams, jellies, preserves, etc.; Kentucky crafts people; and any other category deemed acceptable to the market.
- B. It is recognized that although members sell as individuals, the market is a cohesive unit and its success depends on the cooperation and joint effort of all the vendors as a whole.
- C. Members must make, grow, or harvest 90% of the products they sell at the Market site.
- D. Members are expected to abide by the Market guidelines as set forth by the Market.
- E. Members are required to attend KDA training for WIC and Senior Farmers' Market Nutrition Program.
- F. The Market reserves the right to prohibit anyone from selling at the Market if guidelines are not met.

II. ACCEPTABLE PRODUCTS

- A. The Market will provide an outlet for the sale of fresh picked produce, related agricultural, horticultural and craft products that have been grown, harvested, produced or made by the member. A high standard of quality and freshness is expected.
- B. The market manager shall have the right to prohibit the sale of any unacceptable item.

III. MARKET SITE

- A. The market will be located at Allen County Fairgrounds, 750 Rediger Dr., Scottsville, KY
- B. The market will operate on Wednesday and Saturday mornings 8 AM until 12 Noon.
- C. The opening day will be Saturday, May 20, 2017 and the ending market date will be Saturday, September 2, 2017. Dates could change depending on availability of produce.

IV. MARKET OPERATION

- A. Fresh produce must be displayed at least 12 inches off the ground and 18" from a wall.
- B. Members must post FMNP signs at their stall each market day. (Signs provided by KDA)
- C. "Kentucky Proud" logo should be displayed on produce, POS signs and in market advertising..
- D. Prices must be clearly displayed.
- E. Home-Based Processor Permits must be display with any processed items sold at the market.
- F. To offer samples, you must complete an education program from KDA, then follow guidelines provided.
- G. To accept FMNP checks each member must have GAP training. (Provided by Extension Service)

V. APPEARANCE AND CONDUCT

- A. Members will be neat, suitably dressed, and deal with the public in a courteous and appropriate manner.
- B. All members will display their products neatly and attractively, with consideration for the other members and the general public.
- C. Members are responsible for their own stalls, will supply all necessary trash containers, and will leave their site clean and in a condition acceptable to the market manager and property owner.

VI. MARKET FEES

- A. Producer Member – 1-year membership fee is \$40.00 and entitles the member to sell at the market site.
- B. All fees are non-refundable.

VII. INSURANCE

- A. Liability insurance in amounts and coverage acceptable to the Farmers' Market /property owner, product liability shall be provided by the Market members and general liability by the property owner.

VIII. NON-DISCRIMINATION

- A. The Allen County Farmers' Market does not discriminate on the basis of age, disability, gender, race or religion.
