- Photos must be taken at a Kentucky Farmers' Market
- Photos must capture the people, the enjoyment, beauty, and culture of Kentucky's Farmers' Markets
- Each post should include a single photo. There is no limit to the number of posts that can be submitted
- Photos must be posted on Instagram
  - o Must tag KY Proud Instagram account: @kentuckyproud
  - Must include #KYProudFarmersMarkets
  - o Post must be public to be eligible for prize consideration
