Hemp Program Summary of Varieties: Including Varieties of Concern and Prohibited Varieties

Version KDA-HEMP-2025-0327, Publication Date: March 27, 2025

License holders should review this document before purchasing seed or planting materials. This document provides important guidance for growers based on past THC test results from crops grown in Kentucky. Provided here is a list of all hemp varieties, strains or cultivars that have been approved for use in the Kentucky hemp program. This list contains *Prohibited Varieties* and *Varieties of Concern*, as well as testing data on all other varieties that have been grown and tested in Kentucky since 2017. *Prohibited Varieties* have been proven not to be hemp and are not allowed to be grown in Kentucky. Any variety or strain of hemp not listed in this document requires the submission of the *New Hemp Variety or Strain Request* form and pre-approval from KDA before it can be grown in Kentucky.

Hemp is defined in state and federal law as "the plant *Cannabis sativa L*. and any part of that plant, including the seeds thereof and all derivatives, extracts, cannabinoids, isomers, acids, salts, and salts of isomers, whether growing or not, with a delta-9 tetrahydrocannabinol [THC] concentration of not more than 0.3 percent on a dry weight basis." The measurement of the THC concentration includes both delta-9 THCa and delta-9 THC (often referred to as total THC).

302 KAR 50 provides the following definitions:

- (33) "Prohibited Variety" means a variety or strain of cannabis excluded from the Hemp Licensing Program.
- (44) "Variety of Concern" means any variety of hemp that tests above 0.3000% delta-9-THC in one
 (1) or more pre-harvest samples. A hemp variety designated as a "variety of concern" could be subject to restrictions and additional testing.

Production of Phytocannabinoids (Cannabinoids) in Floral Material

In recent years, a large percentage of the reported acreage planted in Kentucky has been focused on phytocannabinoid production. Phytocannabinoids are a broad class of chemicals or compounds produced primarily in the floral material of the plant; these include THC and other compounds of nutraceutical interest such as cannabidiol (CBD) and cannabigerol (CBG). Current scientific evidence suggests that phytocannabinoids accumulate proportionally, therefore, as growers strive to increase the hemp plant's production of CBD or other phytocannabinoids, there is concern that THC levels may increase above the legal limit for hemp. The Department remains committed to managing its program so that growers produce hemp that meets the legal definition of "hemp" in KRS 260.850(5). To that end, the Department publishes this list to help growers plan their future activities in the Hemp Licensing Program. Be advised that virtually all high-CBD strains of hemp have the potential to test above the legal limit of THC if allowed to fully mature.

Reproduction by Seeds

Purchase seeds from a reputable source offering certified seed if available. Testing data in recent years has suggested that uncontrolled or unintended pollination of clonal female hemp plants will often produce seeds that result in non-compliant cannabis plants in the next generation. Most of the THC test results above 1% have been found to be crops produced from seeds that were obtained from an unknown source or unexpected seeds saved from a previous year's crop or strains from China. It is not advisable to use seeds saved from the previous year's crop, or to clone from volunteer plants.

Varieties of Concern (VOC)

The varieties or strains designated as a *Variety of Concern* (VOC) in the table on the following pages had at least one THC test result above 0.300%. Growers who are considering whether to use these varieties in the future should exercise caution and remain aware of the Department's *Varieties of Concern* designations. These varieties are at a higher risk for exceeding the THC limit that could lead to the ordered destruction of the crop. These designations are subject to change.

Prohibited Varieties

The varieties or strains of cannabis designated as *Prohibited Varieties* in the table below have been prohibited from use in Kentucky. A variety or strain of cannabis may be designated as a *Prohibited Variety* and excluded from the KDA Hemp Licensing Program if:

- a) more than 50% of Pre-Harvest Samples' test results for a given *Variety of Concern* are above 0.300% delta-9-THC,
- b) a Pre-Harvest test result is equal to or greater than 1% delta-9-THC, or
- c) publicly available information supports the fact that the variety or strain is marijuana.

For Varieties determined to be a Prohibited Variety (302 KAR 50):

A license holder shall not buy, sell, possess, or transfer seeds or propagules of any variety or strain designated as a Prohibited Variety on the department's published Summary of Varieties list.

New Varieties

The varieties or strains designated as *NEW* in the table below have been approved for entry into the Kentucky Hemp Program based on an out-of-state certificate of analysis submitted with a *New Hemp Variety or Strain Request* form, but the variety has not yet been grown to harvest or tested in Kentucky. These varieties are eligible to be grown in Kentucky without additional submissions of the *New Hemp Variety or Strain Request* form, but their performance is untested.

Additional Varieties/Strains

The varieties or strains listed in the table below without a designation produced acceptable THC test results and therefore are not currently designated as a *Prohibited Variety* or *Variety of Concern*.
