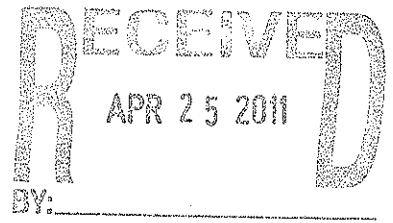


**MONTGOMERY COUNTY FARMERS' MARKET
RULES AND REGULATIONS

1. All vendors must pay a sales fee, good for the 2011 market year. The fee is based upon the following space scale: 15'----\$75; 30'----\$150
2. Market limited to **LOCALLY GROWN & LOCALLY MADE** items by vendors from Montgomery, Bath, Menifee, & Bourbon Counties provided those counties have a reciprocal arrangement. You have to grow or make what you sell. Exception is—Paid vendors may sell other vendor's raised or produced items if properly labeled to show origin.
3. Gardens will be inspected by a member of the Executive Committee and one other vendor or at the executive committee's discretion. Refusal to have your garden inspected will result in expulsion from the market.
4. Anyone caught selling produce or items that they have not grown or made in Montgomery, Bath, Menifee, or Bourbon Counties will be subject to permanent suspension from the market.
5. No alcoholic beverages allowed while at the market site.
6. All vendors are encouraged to stay together on prices.
7. Vendors must have their own certified scales if selling by weight (or have access to certified scales), tables, sacks, etc. Scales must be for Legal Trade and made for Commercial Use.
8. Sale days are Wednesday and Saturday only beginning at approximately 7 am until approximately noon.
9. All vendors must clean their own spaces before leaving.
10. Vendors required to display WIC/SR signs if they accept WIC/SR coupons.
11. Any vendor completing the HB 391 course and are certified, must display their permit.
12. New vendors must make application to the market two weeks prior to selling and be approved by the executive committee. The Executive Committee reserves the right to expel any member who does not follow the rules and regulations, or in anyway is proven to be detrimental to the market. (Applications available from Executive Committee members or at the Montgomery County Extension Office.)
13. Customer Appreciation Day will be held during the market. If you would be willing to volunteer, please indicate on your application. Tentative date is August 6th.
