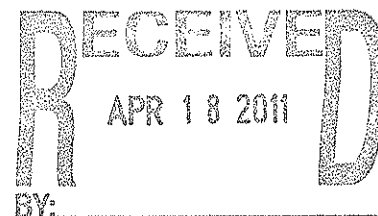


**Owsley County Farmers Market
Rules and Compliance Agreement Form
2011 Season**



OPEN TUESDAY BEGINNING AT 8:00 A.M. AND SATURDAY BEGINNING AT 7:00 A.M. RUNNING FROM JUNE 4 THROUGH OCTOBER 28.

1. Space will be provided on a first come, first served basis each market day within the designated area for Farmers Market Members. Fees will be \$20.00 for the 2011 season.

Types of Products to be sold.

- *All Fruits and Vegetables
 - *Bedding and Potted Plants, Cut Flowers (Are subject to Sales Tax; The Sellers Responsibility).
 - *Baked Goods are allowed (Includes Bread, Cakes, Pies Etc...)With Health Department Certification
 - *No Eggs
 - *No Live Animals, Fresh Meat, Fish, Milk or Milk Products.
 - *Soap (Homemade)
 - *Crafts (Homemade Only)
 - *Home Spun Textiles
2. Produce Must Be In Containers and Kept OFF the Ground.
 3. CLEANUP – ALL Sellers will be responsible for their garbage cleanup.
 4. Participants will provide their own Bags for Customers.
 5. Participants will Display Identification Sign.
 6. Participants will provide their own Tables.
 7. It is up to the Individual Seller to set the price for their Produce/Products However, No intentional undercutting will be permitted without permission.
 8. Any sell not in compliance with the above regulations will first be given a warning and a second violation will result in the seller being asked to vacate the Premises.
 9. I certify that the Produce/Product that I sell was Home Grown or Home Made.
 10. No Purchased Products can be sold for resale without approval from a Committee Member. 10% or less.
 11. The Market is a Drug and Alcohol FREE Area. All producers must conduct themselves as an adult. NO Foul or Vulgar Language will be permitted.

COMPLIANCE AGREEMENT

I, The Undersigned, Have read these rules and regulations governing the Owsley County Farmers Market and agree to comply with the afore mentioned Rules and Regulations. A violation of the Rules/Regulations gives the Owsley County Farmers Market the power to end my Privileges to sell and Revoke my Membership Privileges.

I WILL NOT HOLD THE OWSLEY COUNTY FARM BUREAU OR THE OWSLEY COUNTY SCHOOL DISTRICT RESPONSIBLE IN THE EVENT AN ACCIDENT IN CONNECTION WITH THE OPERATION OF THE OWSLEY COUNTY FARMERS MARKET.
