Call to Order

Deputy Commissioner Warren Beeler presiding, called the Kentucky Agricultural Development Board (KADB) regular business meeting to order at 9:04 a.m. (EST).

Deputy Commissioner Beeler updated the board on activities of the Kentucky Department of Agriculture (KDA).

Executive Director's Report

Deputy Commissioner Beeler called on Brandon Reed to give the Executive Director's Report. Mr. Reed gave an overview of his activities since the November board meeting. Mr. Reed referenced the Large and

Food Animal Veterinary Incentives Program total projects to date and dollar amount. Lastly, Mr. Reed referenced the KADF 2026 Approved Guideline Revisions.

Deputy Executive Director's Report

Deputy Commissioner Beeler called on Bill McCloskey, KOAP Deputy Executive Director, to present the compliance and financial report to the board.

Ms. Charles referenced four (1) CAIP totaling \$223,000; total funding: \$223,000.00

Mr. Denton moved to approve all programs meeting state guidelines, as presented; Mr. Hinton seconded the motion.

VOTE: Motion Passed; Unanimous.

Requested Program Amendments

Deputy Commissioner Beeler called on Ms. Charles to present the requested program amendments.

Ms. Charles referenced one (1) county requests for additional funds for existing CAIP program totaling \$20,587 (Daviess Counties).

Staff recommended approval of these amendments.

Mr. Fields moved to approve staff recommendation, as presented; Dr. Bernard seconded the motion.

VOTE: Motion Passed; Unanimous.

Projects Recommended for Funding

Deputy Commissioner Beeler called on Savanna Hill and Jesse Moore to present the following projects.

A2025-0238 Farmer's choice, LLC

Ms. Hill referenced the above application requesting \$1,052,910 in state fund to purchase a grain cleaner and 4 – 150,000 bushel grain bins with 2 bins dedicated to organic and 2 bins dedicated to conventional grain.

The KADB Application Review and Compliance Committee recommends funding county funds matched by state funds with the difference in a participation loan up to \$150,000, subject to the terms and conditions.

Mr. Hinton moved to fund the applicant in multi-county funds with the option of a KADF participation loan, not to exceed a total of \$250,000. Mr. Pedigo seconded the motion.

VOTE: Motion Passed; Unanimous.

A2025-0247 Sunnyside Egg Co. LLC

Ms. Hill referenced the above application requesting \$120,387 in state funds to scale regenerative egg production.

The KADB Application Review and Compliance Committee recommends funding county funds matched by state funds up to \$89,443, subject to the terms and conditions.

Mr. Denton moved to approve the committee recommendation, as presented; Mr. Fields seconded the motion.

VOTE: Motion Passed; Unanimous.

A2025-0250 Owensboro Catholic Schools

Mr. Moore referenced the above application requesting \$658 in Daviess County funds to purchase grow lights and heat mats for their greenhouse.

The KADB Application Review and Compliance Committee recommends funding the applicant up to \$658 in Daviess County funds, subject to the terms and conditions.

Mr. Giesecke moved to approve the committee recommendation, as presented; Ms. Graham seconded the motion.

VOTE: Motion Passed; Unanimous.

Projects Recommendations for No Funding

A2025-0127 Kentucky Milk Company

Becca Besok referenced the above application requesting \$25,000 in multi-county funds and \$25,000 in state funds for the purchase of a dairy processing equipment.

The KADB Application Review & Compliance Committee recommends not funding the application due to limited producer impact. The KADB Application Review & Committee recommends the applicant pursue a loan through KAFC.

Mr. Hinton moved to approve the committee recommendation, as presented; Dr. Jones seconded the motion.

VOTE: Motion Passed; Mr. Foree Opposed.

A2025-0249 Grown Up Harvest Grocery, Inc.

Mr. Moore referenced the above application requesting \$197,000 in state funds to build an expansion inaugural location such as 2,500 square-foot indoor farmers market and grocery in Louisville Nulu neighborhood.

The KADB Application Review & Compliance Committee recommends not funding the application due to limited producer impact.

Mr. Denton moved to approve the committee recommendation, as presented; Mr. Fields seconded the motion.

VOTE: Motion Passed; Unanimous.

A2025-0248 Red Haven Farm, LLC

Alexis Scheidt referenced the above application requesting \$387,277 in multi-county and state funds to construct the Red Haven Country Store, a rural retail hub connecting local producers with the community.

The KADB Application Review & Compliance Committee recommends not funding the application due to limited producer impact.

Mr. Foree moved fund the applicant up to \$70,000 in multi-county funds; Ms. Graham seconded the motion.

VOTE: Motion Passed; Unanimous.
