A2021-0023 Riverview Meat Company LLC

Ms. Milbern referenced the above application requesting \$250,000 in State funds to purchase an existing meat processing facility in Cynthiana, KY. This project is a MPIP Level 4.

The Meat Processing Expansion Committee recommended funding \$250,000 in State funds as a forgivable loan and any county funds secured shall be awarded in the form of a cost-reimbursement grant in addition to State funds, subject to terms and conditions.

Mr. McKee moved to approve the committee recommendation, as presented: Mr. Giesecke seconded the motion.

VOTE: Motion Passed; Unanimous.

A2021-0042 Continental Refining Company

Ms. Milbern referenced the above application requesting \$250,000 in Pulaski County funds and \$4,750,000 in State funds to establish a soybean processing facility.

The Red Application Review Committee recommended funding the request and allow KADF funds go towards the crush portion of this project. State funds to be matched by county funds in the form of a cost reimbursement grant, up to \$500,000 and to allow the applicant six (6) months to secure county funds, subject to terms and conditions.

Mr. Foree moved to approve the committee recommendation, as presented; Mr. Hunt seconded the motion.

A2021-0052 Clark County Fiscal Court

Ms. Milbern referenced the above application requesting \$35,020 in Clark County Funds to build a compost facility to compost dead animals.

The Red Application Review Committee recommended funding the request for up to \$10,000 in Clark County funds based on the Clark County Agricultural Development Council recommendation. The Clark County funds will be available in the form of a cost reimbursement grant to construct the building part of this project, subject to terms and conditions.

Mr. Giesecke moved to approve the committee recommendation, as presented; Ms. Butler seconded the motion.
