

## WHAT IS A DISASTER/SITUATION OF DISTRESS?

• "Disaster" can be any natural catastrophe regardless of any cause fire, flood, explosion, in any part of the US, which the president determines causes damage of sufficient magnitude to warrant federal assistance.


"Situation of distress" means a natural catastrophe in which the state distributing agency of food nutrition services (FNS) warrants the use of USDA-donated foods.







## DIFFERENCE BETWEEN DISASTER AND SITUATION OF DISTRESS



DISASTER	SITUATION OF DISTRESS
Requires a Presidential declaration that Federal assistance is warranted.	No Presidential declaration is required.
Guaranteed replacement of USDA Foods by FNS.	Replacement of donated foods by FNS to the extent that funds for replacement are available.
State Distributing Agency has authority to release donated foods for congregate feeding, for as long as they are needed, without FNS approval.	State Distributing Agency has the authority to release donated foods for congregate feeding, only for up to 30 days. If not a normal event, FNS Headquarters must approve and determine duration of assistance.

- EARLY AND FREQUENT COMMUNICATION IS CRITICALLY IMPORTANT
- ESTABLISH A DISASTER RESPONSE TEAM
   FOR YOUR DISTRICT
- NOW YOUR EMERGENCY MANAGEMENT



## PLAN AND PREPARE


- **UPDATE THE PLAN ANNUALLY**
- **ESTABLISH RECORDKEEPING**PROCEDURES
- IDENTIFY AND DEVELOP RELATIONSHIPS WITH DA CONTACTS AND LOCAL DISASTER ORGANIZATIONS SUCH AS EMERGENCY MANAGEMENT



## RA PREPARATION

- MAINTAIN EMERGENCY CONTACT LISTS TO INCLUDE WORK NUMBERS, CELL NUMBERS, AND E-MAIL ADDRESSES OF DESIGNATED DISASTER PERSONNEL AND CENTRAL OFFICE
   ADMINISTRATION
- PROVIDE EMERGENCY RA CONTACT INFORMATION TO ESSENTIAL DA PERSONNEL
- ASSESS CURRENT INVENTORIES OF USDA FOODS THAT MAY BE NEEDED TO SUPPLEMENT NON-GOVERNMENTAL ORGANIZATIONS AND STATE EMERGENCY RESPONSE AGENCIES AND REPORT USDA FOODS INVENTORIES TO DA IF REQUESTED
- PROVIDE LOCATION, DATES, AND TIMES FOR DISASTER FEEDING TO THE DA

- COMPILE USDA FOODS INVENTORY INFORMATION
- ESTABLISH/MAINTAIN/UPDATE EMERGENCY CONTACT INFORMATION FOR ALL KEY PLAYERS



- EECOME FAMILIAR WITH THE APPROVAL PROCESS FOR USING USDA FOODS IN DISASTERS
- COORDINATE AND COMMUNICATE ALL NECESSARY INFORMATION WITH PARTNERS AT YOUR STATE AND LOCAL GOVERNMENT LEVEL AND WITH NON-GOVERNMENTAL ORGANIZATIONS



RAS SHOULD PROVIDE TRAINING FOR APPLICABLE STAFF ON THE DISASTER PLAN AND THE ROLE OF USDA FOODS ANNUALLY



## RA RESPONSE DURING A DISASTER

- PROVIDE DAILY UPDATES ON SHELTERING POPULATIONS, IF APPLICABLE
- REPORT USDA FOODS USED FOR DISASTER FEEDING (CONGREGATE AND DHD) TO DA
- IF REQUESTED, PARTICIPATE IN CALLS WITH DA TO PROVIDE LOCAL UPDATES
- BEFORE A DISASTER, DEVELOP AND MAINTAIN RELATIONSHIPS WITH YOUR STATE AND COMMUNITY PARTNERS SO YOU KNOW WHO TO CONTACT WHEN A DISASTER EVENT OCCURS
- AFTER A DISASTER, CONDUCT AN AFTER-ACTION TO CRITIQUE AND EVALUATE ACTIONS TAKEN DURING THE DISASTER



#### **Benefits of USDA Foods in Disasters**

- Provided free of charge to local disaster feeding organizations
- Transportation costs are covered
- State completes the paperwork for reimbursement/replacement of Foods
- Nutritious/Support American agriculture



## USDA FOOD REQUESTS FOR DISASTER RELIEF ORGANIZATIONS

- The Kentucky Department of Agriculture (KDA) may release usda foods maintained in schools to approved disaster relief agencies such as red cross, salvation army and religious based organizations. In most instances the red cross is the primary organization responsible for coordinating disaster feeding.
- The Food Nutrition Service (FNS) will only reimburse usda foods used for feeding efforts through KDA approved disaster agencies during disasters or a situation of distress- districts that choose to donate foods to unauthorized agencies/groups will not be reimbursed through FNS
- Disaster relief organizations prefer institutional pack size over household foods for emergency feeding, such as those used in the national school lunch program as they are easier to handle and guarantee replacement under presidentially declared disasters.
- Although processed foods are USDA foods and can be released to disaster relief organizations. USDA will "only" reimburse the value of the raw USDA product contained in the further processed item.

### KDA EMERGENCY INVENTORY REPORT FD-52

- During an impending disaster/emergency, you may be emailed the KDA Emergency Inventory report (KY-FD-52) and asked by your KDA food distribution regional ag inspector to complete the form for your district.
- Complete the KY-FD-52 for each school within your district. List the types of USDA"Brown Box" foods only, sales order number and quantities of these foods you have on hand for each school.
- Compile totals for all schools on one "electronic" KY-FD-52 form and email it your regional ag inspector. Do not scan, fax or copy this form.
- KDA needs KY-FD-52-inventory report within 6 hours upon request.



## USDAFOOD EMERGENBY FEEDING REPORT ED-50

- Once donated foods are requested by the KDA to be released to disaster relief organizations, it is essential that local agencies keep track of these products using the USDA food emergency feeding report KY-FD-50 once this form is completed send it in electronically to your regional ag inspector asap!
- KDA has 45 days from termination of the emergency assistance to request commodity replacement in a declared disaster or 30 days during a situation of distress.
- Make certain that all fields on the KY-FD-50 contain all relative information insuring each section is completed on the form properly before submitting to your regional ag regulatory specialist.

## WHAT DO I DO IF THE RED GROSS REQUESTS USDA FOODS?

- The red cross will notify KDA to request which USDA foods they will need from your district for disaster feeding.
- "If" the red cross needs your district's foods, your regional Ag Regulatory Specialist will let you know which foods/quantities you listed on your KY-FD-52 that will need to be pulled from each school site.
- Prepare these foods for pickup
- School sites can also release USDA purchased foods of the same type/quantity.
- The red cross member/volunteer will be required to show identification to you/your staff prior to releasing these USDA foods



### HOW CAN MY SCHOOL DISTRICT PREPARE FOR A DISASTERP

- Develop a plan- it is very important that every district puts in place a disaster preparedness plan.
   This will assist you in the event of a disaster/emergency
- Methods if identification
  - Red marker/color stickers
  - Separation of USDA foods and purchased foods

Having district and school administrative staff with radios that have the local first responder channels is helpful. Local 911 dispatch should have all school channels.

## WHEN WILL MY DISTRICT BE REIMBURSED FOR OUR USDA FOODSP

- Your districts report will be submitted to the food and nutrition service (FNS) southeast regional office for reimbursement once the disaster feeding is completed
- Under a Presidentially declared disaster, FNS guarantees replacement/reimbursement of USDA foods used in the disaster feeding. There is no set time within the USDA foods program as to when districts will be reimbursed.

#### USDA Foods Complaint Procedures for RA

TO ASSIST YOUR SDA IN PROCESSING THE COMPLAINT MORE QUICKLY, PROVIDE THE FOLLOWING INFORMATION:

- CAN AND CASE CODES.
- DESCRIPTION OF THE PROBLEM AND WHETHER ANYONE REPORTED FEELING SICK OR BEING INJURED FROM CONSUMING THE PRODUCT.
- DATE YOUR ORGANIZATION RECEIVED THE AFFECTED USDA FOODS.
- QUANTITY OF PRODUCT INVOLVED (AFFECTED).
- QUANTITY AND PHYSICAL ADDRESS OF PRODUCT REMAINING AND IF THE REMAINING PRODUCT IS AFFECTED OR NOT.
- SALES ORDER NUMBER (FORMERLY DELIVERY ORDER NUMBER) AND PURCHASE ORDERNUMBER (FORMERLY NOTICE TO DELIVER NUMBER). THESE NUMBERS MAY BE ON THE PAPERWORK REVIEVED WITH THE USDA FOOD SHIPMENT. IF NOT, THE SDA SHOULD BE ABLE TO OBTAIN THEM.
- THE SPECIFIC CIRCUMSTANCES INVOLVED. FOR EXAMPLE- I RECEIVED THE DAMAGED CANNED PRODUCTS 2 MONTHS AGO, BUT THE CASES WERE LOCATED IN THE MIDDLE OF THE PALLET THAT COULD NOT BE SEEN UNTIL THE SCHOOL OPENDED THE CASES. OR, THE TEMPERATURE ON THE DELIVERY TRUCK WAS 40 DEGREES WHEN THE DISCOLORED FROZEN PRODUCTS WERE DELIVERED.
- IN SOME INSTANCES, DIGITAL PHOTOGRAPHS OF DAMAGED PRODUCT OR FOREING OBJECTS ARE HELPFUL.
