

Accepting a wide variety of unprocessed/minimally processed products like fruits, vegetables, seafood, meat, poultry, eggs, etc.







Federal Farm to Food Banks Program

- Farm to Food Bank Projects must have a purpose of:
- ► (A) Reducing food waste at the agricultural production, processing, or distribution level through the donation of food;
- ► (B) Providing food to individuals in need; and
- (C) Building relationships between agricultural producers, processors, and distributors and emergency feeding organizations through the donation of food.
- Project funds may only be used for costs associated with harvesting, processing, packaging, or transportation of unharvested, unprocessed, or unpackaged commodities donated by agricultural producers, processors, or distributors for use by emergency feeding organizations.


