

2017 FLEMING COUNTY FARMERS MARKET RULES

Market Chairman – Jeremy Myers Market Vice Chairman – Bruce Barnes Secretary / Treasurer – Alice Myers

- 1. The market is open to Fleming and all adjoining counties.
- 2. All produce must be locally grown. Buying and reselling is grounds for immediate expulsion.
- 3. Annual dues will be set at \$ 35 per farm operation. All dues must be paid on or before May 15th in order to be considered a "member" in good standing. The term "member" shall be defined as a Farm Operation. Which are family members and/or farm representatives that have been trained and have attended all mandatory meetings and have paid their dues. Member selling space is 20' x 10'. Membership year runs from March of that year to February of the next.
- 4. Only members in good standing can vote in decisions making policies. A quorum consists of half the membership.
- 5. Members must provide their own scales (Legal for Trade) and containers.
- 6. Days of operation:

- 7. No member may begin selling before designated selling times.
- 8. Marketing spaces are assigned first come. Members cannot park overnight or leave unattended vehicle to hold a spot.
- 9. All members must be courteous to other members, which includes no alcohol, no profanity, and no abusive or threatening behavior toward members or clients. These activities will result in immediate expulsion.
- 10. Pricing will not be fixed but members will keep their prices competitive. Members may only advertise prices at their sales area and may only do it with signs.
- 11. Members must clean up their market area before leaving.
- 12. Booth certificates will be issued and must be displayed prominently at member's market space.
- 13. Members must read and sign a copy of the rules of the Fleming County Farmers Market as well as fill out the information sheet on where in the county your farm is located. Location is defined as address of farm or ASCS office farm location number.
- 14. The executive committee reserves the right to inspect a member's farm if problems arise.
- 15. Executive committee will handle any or all complaints. Executive committee has the right to decline or revoke membership.
- 16. Executive committee will consist of Chairman, Vice Chairman and one member at large. The executive committee will appoint the member at large.
- 17. Officers will be elected every other year, beginning in 2004.
- 18. Members must attend 3 mandatory membership meetings between January and May. (Any absence must receive prior approval from the Executive committee. In the case of an emergency, the Executive committee will decide if a member can be excused and still join the market.)
- 19. WIC and Sr Voucher training is mandatory and must be done by all members. WIC and SR Voucher training may or may not be listed as one of the 3 mandatory meetings. If it is then the member must attend even if they do not choose to accept the vouchers.
- 20. GAP training is also required for all new members and all members who already have their GAP training must complete updates per state changes. GAP training will not be included as one of the mandatory meetings.
- 21. All rules must be compliant with the KY Farmers Market Manual.
