The Kentucky Department of Agriculture (KDA) continues to follow leads and opportunities to locate viable quantities of hand sanitizer for Kentucky's Farmers' Markets. - On behalf of Kentucky's Farmers' Market, KDA has contacted the central location for Kentucky distilleries to inquire if there are opportunities to pursue competitive wholesale pricing. Each Farmers' Market may wish to make individual inquiries. Currently, ensuring adequate supplies for the healthcare industry is top priority and individual distillery prices may be high:
