General Rules & Regulations for Kentucky Proud™ Livestock Classic

1. The Kentucky Proud™ Livestock Classic is open only to Kentucky youth exhibitors and Kentucky Proud™ animals. All animals exhibited must be the *bona fide* property of the youth exhibitor. All entries must be an approved livestock project under the supervision of an extension agent or vocational agriculture instructor. All youth exhibitors from both 4-H and FFA youth organizations will show together in all classes.
2. All animals exhibited are required to have a Kentucky Proud™ tag through the ear at the time of check-in. Entries are only eligible if tag is fully intact and through the animal's ear. If tags are through another tag, on the halter, in your show box or only one side is with a different tag they will NOT be accepted as an official Kentucky Proud™ tag.
3. All Youth Exhibitors are required to present a completed copy of the Kentucky Proud™ Ownership Affidavit for each species at time of entry. Any entry that is considered by the Show Committee to be a hazard to exhibitors, spectators, etc. will be excused from the show and will be ineligible for class placement and premiums.
4. All species not meeting the minimum entries for their respective show will be shown in an AOB (All Other Breeds) class.
5. All entries must conform to the official health regulations governing the exhibition of livestock in Kentucky. All animals exhibited in the Kentucky Proud™ Livestock Classic shall be identified individually on a health certificate. All Kentucky origin animals for exhibition shall be individually identified on a Certificate of Veterinary Inspection (CVI) written in the current calendar year (Jan. 1 through Dec. 31, 2025). 6. The Kentucky Proud™ Livestock Classic Show Committee (see page 15) shall have the authority to enforce and interpret any and all rules. Due to space limitations, exhibitors may be asked by the Show Committee to tighten up or share pen or bedding areas. The committee's decisions are final.
7. All livestock classes must be shown by youth, and all adults shall remain outside the show ring. Each youth exhibitor must show his/her animal unless incapacitated or has more than one entry in the class. Then, another youth exhibitor the same age or younger may show the animal. Youth exhibitors are expected to treat their animals in a manner consistent with good animal husbandry, and display proper sportsmanship at all times.
8. All youth exhibitors are responsible for making entries during the posted time on page 13. The official judges' decisions are final.
9. Owners must furnish all feed and bedding for their animals.
10. If a youth exhibitor violates any of the rules and regulations of the Kentucky Proud™ Livestock Classic, they will be denied the opportunity to participate in the event and forfeit all premiums won.
11. The Top Five will be selected in each show. (i.e. Market Lamb & Commercial Ewe Lamb, Market Beef & Beef Heifer etc.) A youth exhibitor will only be eligible to receive one honor per show. For example if you have 3 lambs, two market and one commercial, you are eligible to receive Champion Market Lamb and Champion Commercial Ewe Lamb but you cannot receive champion and reserve champion market lamb.

For Kentucky Proud™ Livestock Classic: Market Animal Check-In

1. Market animal youth exhibitor is responsible for turning in their completed weight card by the time listed.
2. All market animals will be weighed and checked in by show staff during the listed time. The Kentucky Proud™ Livestock Classic will not be a declared weight show or have weigh backs.
3. All animals will be weighed prior to showing and classes will be broken by weight determined during check-in.

Beef Market Division

1. All market animals (steers and heifers) must be Kentucky Proud™ tagged and present a completed copy of the Kentucky Proud™ Ownership Affidavit at time of entry. (see page 3 for information)
The ownership deadline for beef market animals is June 1 of the current calendar year. Beef market youth exhibitors are not limited on number of entries. All entries must be trained on the halter.
2. Beef market youth exhibitors must be no more than 21 years of age and no younger than 9 years of age as of January 1, 2025.
3. MARKET STEERS - Market steer breed classes have been added to beef market animal shows. The breed steers must have a registration certificate issued by a breed association. Breed classes will be offered for breeds with more than 2 head. If there are less than 2 head, these entries will show in an AOB class. A Crossbred steer class will be offered for steers without a registration certificate. No bulls or bullocks will be eligible in the steer classes.
4. Market steers will be shown by breed and weight with crossbreds following purebred classes.
5. A Breed Champion and Reserve Breed Champion Market Steer will be selected for each breed.
6. MARKET HEIFERS— Market Heifers will show by weight only, not by breed. Market Heifers must be open.
7. A Champion and Reserve Champion Market Heifer will be selected.
8. All Breed Champion Market Steers and Reserve Breed Champion Market Steers along with the Champion Market Heifer and Reserve Champion Market Heifer will compete for the top five honors in the Beef Market Animal Champion Drive. A youth exhibitor may only win one honor in the Beef Market Animal Champion Drive.

Beef Heifer Division

1. All Beef Heifers and Cow/Calf pairs must be Kentucky Proud™ tagged and present a completed copy of the Kentucky Proud™ Ownership Affidavit at time of entry. (see page 3 for information)
2. All breed females must be registered in the youth exhibitor's name in order to show in the registered division of the show. Entries must be owned by youth exhibitor by June 1 of the show year and positively identified per breed association requirements. Beef market youth exhibitors must be no more than 21 years of age and no younger than 9 years of age as of January 1, 2025.
3. All Commercial Heifers must be Kentucky Proud™ tagged and be listed on the Ownership Affidavit.
4. All commercial heifers must be permanently identified by legible tattoo or brand and be in the possession of the youth exhibitor by June 1 of the show year.
5. Commercial heifers can be exhibited in the commercial division only and will show by weight.
6. Any heifer that has been issued a registration certificate by a purebred breed association is not eligible to show in the commercial division.
7. All heifers must be trained on the halter.
8. Youth exhibitors are not limited on number of entries.
9. Heifers must have been born between September 1, 2023 and April 30, 2025 to compete in the show.
10. Cow/Calf pairs will be eligible. Calves cannot be older than 210 days.
11. Breeds must have three (3) head in order to have a breed show. If the minimum of three head cannot be met, the breed will show in an AOB or AOB Percentage class according to the registration papers.
12. A purebred cow with percentage calf will be classed within the breed of the cow.
13. All Breed Champion Females and Reserve Breed Champion Females will compete for the top five honors in the Beef Heifer Champion Drive. A youth exhibitor may only win one honor in the Beef Heifer Champion Drive.

Dairy Division

1. All Dairy Heifers and Cows must be Kentucky Proud™ tagged and present a completed copy of the Kentucky Proud™ Ownership Affidavit at the time of entry. (see page 3 for information)
2. All registered dairy animals must be registered in the name(s) of the 4-H Club member(s) or FFA member(s) exhibiting them and registration papers must be shown at time of check in. The transfer of registration or date of ownership, as prescribed by particular breed associations, must be recorded in the breed office prior to June 1 of the current year. If the registration certificate has not been received from the breed association, a statement from the association that the transfer has been recorded prior to June 1 will be acceptable.
3. All grade dairy animals shown must be the *bona fide* property of the 4-H Club member or FFA member and part of the member's program. Certificates of ownership of grade dairy animals must be shown on approval forms and presented at the time of checking in animals. These forms are to be completed prior to arriving at the show.
4. Chapter or Club members participating in the lease program must have possession of the animal by June 1 of the current year.
5. Registered and grade dairy animals will be shown in competition with each other within their respective breed classes.
6. A dairy youth exhibitor is not limited on number of entries, both cows and heifers. Dairy youth exhibitors must be no more than 21 years of age and no younger than 9 years of age as of January 1, 2025.
7. All Breed Champions and Reserve Breed Champions will compete for the top five honors in the Dairy Champion Drive for the heifer division and cow division.
8. A youth exhibitor may only win one honor per division.

Market Hog Division

1. All market hogs must be Kentucky Proud™ tagged and present a completed copy of the Kentucky Proud™ Ownership Affidavit at the time of entry. (see page 3 for information)
2. To be eligible to exhibit in the Kentucky Proud™ Livestock Classic Market Hog Show, the youth exhibitor must not be more than 21 years of age and no younger than 5 years of age as of January 1, 2025. Swine youth exhibitors are not limited on number of entries of market hogs. The ownership deadline for market hogs is August 1 of the current calendar year.
3. Registered classes will be offered for market hogs. Registration papers must be brought to weigh-in in order to enter in registered classes or they will be shown in the crossbred classes.
Each breed must have three (3) head to have a breed show. If three head cannot be met, hogs can be shown in the AOB division.
4. Market Hogs will be shown by weight with no weight limits.
5. Classes will be determined by breed and crossbred, with weights divided as equally as possible among the entries.
6. Barrows and/or gilts are eligible to be shown. Gilts may only be shown once in either the market hog division or the breeding gilt division.
7. Any animal on-foot showing evidence of staginess, incomplete castration, crippling, or disease will be eliminated.
8. All Breed Champions and Champion Crossbred Market Hog and Reserve Breed Champions and Reserve Crossbred Market Hog will compete for the top five honors in the Market Hog Champion Drive. A youth exhibitor may only win one honor in the Market Hog Champion Drive.

Breeding Gilt Division

1. All breeding gilts must be Kentucky Proud™ tagged and present a completed copy of the Kentucky Proud™ Ownership Affidavit at the time of entry. See page 3 for (information)
2. To be eligible to exhibit in the Kentucky Proud™ Livestock Classic Breeding Gilt Show, the youth exhibitor must not be more than 21 years of age and no younger than 5 years of age as of January 1, 2025. Swine youth exhibitors are not limited on number of entries of breeding gilts. The ownership deadline for breeding gilts is August 1 of the current calendar year.
3. Registered classes will be offered for breeding gilts. Registration papers must be brought to weigh-in in order to enter in registered classes or they will be shown in the crossbred classes. Gilts may only be shown once in either the market hog division or breeding gilt division.
4. Each breed must have three (3) head to have a breed show or will be moved to AOB division.
5. Breeding Gilts, both registered and crossbred, will be shown by weight with no weight limits.
6. Classes will be determined by breed and weight, divided as equally as possible among the entries.
7. All Breed Champions and Crossbred Champion Breeding Gilt and Reserve Breed Champions and Reserve Crossbred Gilt will compete for the top five honors in the Breeding Gilt Champion Drive. A youth exhibitor may only win one honor in the Breeding Gilt Champion Drive.

Market Goat Division

1. All market goats must be Kentucky Proud™ tagged and present a completed copy of the Kentucky Proud™ Ownership Affidavit at the time of entry. (see page 3 for information)
2. To be eligible to exhibit in the Kentucky Proud™ Livestock Classic Market Goat Show, the youth exhibitor must not be more than 21 years of age and no younger than 5 years of age as of January 1, 2025. Goat youth exhibitors are not limited on number of entries of market goats. The ownership deadline for market goats August 1 of the current calendar year.
3. All market goats will be shown by weight and must weigh a minimum of 35 pounds at the time of the check-in to be eligible for exhibition. No muzzles, etc., may be used at any time.
4. Wethers and/or does are eligible to show.
5. Does may only be shown once in either the market show or the wether dam classes.
6. All male goats must be clean castrated, banded or surgically removed. Clamping is not allowed prior to the arrival on the grounds. All scrotal tissue is to be removed. No muzzles, etc., may be used at any time.
7. A Division Champion and Division Reserve Champion and third place will be selected out of all weight divisions to compete in the Market Goat Champion Drive.
8. The top three winners in each division will compete for the top five honors in the Market Goat Champion Drive. A youth exhibitor may only win one honor in the Market Goat Champion Drive.

Wether Dam Division

1. All wether dams must be Kentucky Proud™ tagged and present a completed copy of the Kentucky Proud™ Ownership Affidavit at the time of entry. (see page 3 for information)
2. To be eligible to exhibit in the Kentucky Proud™ Livestock Classic Wether Dam Show, the youth exhibitor must not be more than 21 years of age and no younger than 5 years of age as of January 1, 2025. Wether Dam youth exhibitors are not limited on number of entries of wether dams. The ownership deadline for wether dams is August 1 of the current calendar year.
3. Does may only be shown once in either the market show or the wether dam classes.
4. Wether Dams will show by weight and must weigh a minimum of 35 pounds at the time of the check-in to be eligible for exhibition. No muzzles, etc., may be used at any time.
5. Wether dams will be shown in Fitted and Slick Divisions. The top five in each division will be eligible to compete for the top five honors in the Wether Dam Champion Drive. A youth exhibitor may only win one honor in the Wether Dam Champion Drive.

Market Lamb Division

1. All market lambs must be Kentucky Proud™ tagged and present a completed copy of the Kentucky Proud™ Ownership Affidavit at the time of entry. (see page 3 for information)
2. To be eligible to exhibit in the Kentucky Proud™ Livestock Classic Market Lamb Show, the youth exhibitor must not be more than 21 years of age and no younger than 5 years of age as of January 1, 2025. The ownership deadline for market lambs is August 1 of the current calendar year.
3. Market lamb youth exhibitors are not limited on number of entries of lambs. Market Lambs will show by breed and weight. Classes will be broken at the discretion of the Show Committee.
4. All breeds shall be declared at time of check-in. Once a breed has been declared, it cannot be changed. All entries will be shown in breed classes as declared and at the discretion of the show committee.
5. There must be three (3) lambs in order to have a breed show. If three (3) head cannot be met, lambs will show in the AOB division.
6. Wool lambs must be docked, clean castrated, and the animal must be shorn slick above the knee and hock joint (1/4 inch or less) prior to check-in. The minimum weight limit is 60 pounds, with no upper weight limit. All blankets must be removed for inspection before entering check-in. No artificial color may be used. No muzzles, etc., may be used at any time.
7. Hair lambs must be clean castrated. Docking is optional. The minimum weight limit is 35 pounds with no upper weight limit. All blankets must be removed for inspection before entering check-in. No artificial color may be used. No muzzles, etc., may be used at any time. Induced cryptorchids, short scrotum lambs and ram lambs may not be shown.
8. All Breed and Crossbred Champion Market Lambs and Reserve Breed and Crossbred Champion Market Lambs will compete for the top five honors in the Market Lamb Champion Drive. A youth exhibitor may only win one honor in the Market Lamb Champion Drive.

Commercial Ewe Lamb Division

1. All commercial ewe lambs must be Kentucky Proud™ tagged and present a completed copy of the Kentucky Proud™ Ownership Affidavit at the time of entry. (see page 3 for information)
2. To be eligible to exhibit in the Kentucky Proud™ Livestock Classic Commercial Ewe Lamb Show, the youth exhibitor must not be more than 21 years of age and no younger than 5 years of age as of January 1, 2025. The ownership deadline for commercial ewe lambs is August 1 of the current calendar year.
3. Lamb youth exhibitors are not limited on number of entries.
4. All lambs will show by weight classes at the discretion of the Show Committee. Lambs may only be shown once in either the Market Lamb Division or the Commercial Ewe Lamb Division.
5. Wool lambs must be docked and the animal must be shorn slick above the knee and hock joint (1/4 inch or less) prior to check-in. The minimum weight limit is 60 pounds, with no upper weight limit. All blankets must be removed for inspection before entering check-in. No artificial color may be used. No muzzles, etc., may be used at any time.
6. Docking is optional for hair lambs. The minimum weight limit is 35 pounds with no upper weight limit. All blankets must be removed for inspection before entering check-in. No artificial color may be used. No muzzles, etc., may be used at any time.
7. A Division Champion and Division Reserve Champion and third place will be selected out of all weight divisions to compete in the Commercial Ewe Lamb Champion Drive.
8. The top three winners in each division will compete for the top five honors in the Commercial Ewe Lamb Champion Drive. A youth exhibitor may win one honor in the Commercial Ewe Lamb Champion Drive.

Photo Contest

The Kentucky Proud™ Classic Photo Contest is designed to provide youth exhibitors with the opportunity to learn photographic skills and compete with other youth.

Contest divisions are as follows: **Senior, Junior and Novice.**

General contest rules for all age divisions are as follows:

1. Color and black & white photos highlighting your Kentucky Proud™ Project will compete in one category.
2. Judges will rank the top 3 photos in each age division. Awards will be given to the top three in each age division.
3. Contest is limited to 2 entries per person.
4. Photos must highlight Kentucky Proud™ Projects on the farm or at an event. The project should be the dominant focus of the photo.
5. All entries must be entered by 9:00 a.m., September 6, 2025. When entering a photo, you must include the following: contestant name, age, age division as of January 1, 2025 and title of photo.
6. Entries should be formatted and printed as a high quality at 8" x 10" size.
7. All entries must be original, untouched photos taken by the youth exhibitor who enters the photo. Photos must be the contestant's current year's project and cannot have been presented for competition at any other event.
8. The Kentucky Department of Agriculture staff reserves the right to utilize any photos in the contest at the staff's discretion.

Prepared Speech Contest

Contestants will present a speech on a subject for the livestock industry.

Contest divisions are as follows:

Senior Division – 4 to 6 minute speech.

Junior Division – 3 to 5 minute speech.

Novice Division – 2 to 4 minute speech.

General contest rules for all age divisions are as follows:

1. Contestant may choose any subject for the livestock industry. The speech is to be of original content and is to be composed solely by the speaker. Contestant is encouraged to have speech memorized but will be permitted to use notes.
2. Contestant will be asked to answer questions relating to his or her speech following their presentation. The question and answer session shall be a maximum of 3 minutes, with 1 question to be asked per judge. Deductions of 20 points per minute will be taken from the score of each judge for any speech under the minimum or over the maximum time restriction.
3. Contestant must bring to the Kentucky Proud™ Classic 3 typewritten, double-spaced copies of speech on 8 1/2"x11" white bond paper and deliver to the entry desk no later than 9:00 a.m. on September 6, 2025.
4. Contestants are required to include a cover sheet to their speech that lists the following information: name, address and age as of January 1, 2025.
5. Contestants will be judged on personal presentation and content.

Skill-a-thon Contest

The contest will be in a power point format. Contest divisions are as follows: **Senior, Junior and Novice.**

These types of multiple choice questions may be asked.

Hay Judging

1. Contestants in the Skill-a-thon Contests shall check-in with the contest coordinator or their representative on the day of the contest at least 15 minutes prior to the scheduled starting time.
2. Contestants should bring a blank steno pad, clipboard, blank paper, calculator (simple 4 function), and writing instruments. Contestants may not bring books, notes, pamphlets, reference materials, or cell phones into the contest area.
3. Parents will not be allowed to go through the contest with their children.
4. This contest covers the understanding and practical application and the principles of Animal Sciences related to beef, dairy, sheep, swine and goats.

Sales Talk Contest

Contest is designed to give contestants experience in selling a Kentucky Proud™ Project to potential buyers.

Contest schedule and divisions are as follows:

Novice Division – 2 to 5 minute presentation.

Junior Division – 3 to 8 minute presentation.

Senior Division – 3 to 8 minute presentation.

General contest rules for all age divisions are as follows:

1. Contestants are allowed to have one youth participant to assist with the presentation.
2. Kentucky Proud™ Livestock Projects should be referenced in the sales talk.
3. Livestock Supplies and Feed Stuffs associated with Kentucky Proud™ may be referenced in the sales talk.
4. At the time of presentation, original registration papers of registered animals must be presented to the judges. (Additional copies may be provided for all judges.)
5. Contestants may use promotional items that assist in the presentation of the talk. (farm signs, etc.)
6. Contestants engaging judges in the presentation are encouraged, but questions by judges should be held until the end of the contestants' presentation.
7. Presentations should include but are not limited to the following:
 - Species Information
 - Performance Information
 - Visual Characteristics
8. A warning will be given when one minute is remaining in presentation time.
9. Contestants will be evaluated by the following categories:
 - Contents of Sales Presentation
 - Communication Skills
 - Organization
 - Overall Effectiveness
 - Knowledge and Response to Questions

Showmanship Classes

1. Showmanship classes will be divided by age as of the day of the show. Classes will be broken at the discretion of the Show Committee. The winner of each class will compete for the Overall Champion of each species.
2. All youth exhibitors must show their own animals.
3. Youth exhibitors can only show in 2 out of 5 species showmanship classes.
4. To be eligible to participate in Beef and Dairy Showmanship youth exhibitors must be no more than 21 years of age and no younger than 9 years of age as of January 1, 2025.
5. Beef Heifer and Steer youth exhibitors will show together in beef showmanship.
6. Dairy Heifer and Cow exhibitors will show together in dairy showmanship.
7. Small Animal (lambs, swine and goats) will have showmanship divisions for youth exhibitors no more than 21 years of age and no younger than 5 years of age as of January 1, 2025.
8. Market Lamb and Commercial Ewe Lamb youth exhibitors will show together in Lamb Showmanship.
9. Market Hog and Breeding Gilt youth exhibitors will show together in Swine Showmanship.
10. Market Goat and Wether Dam youth exhibitors will show together in Goat Showmanship.

Premiums will be paid in showmanship classes. The scale is as follows:

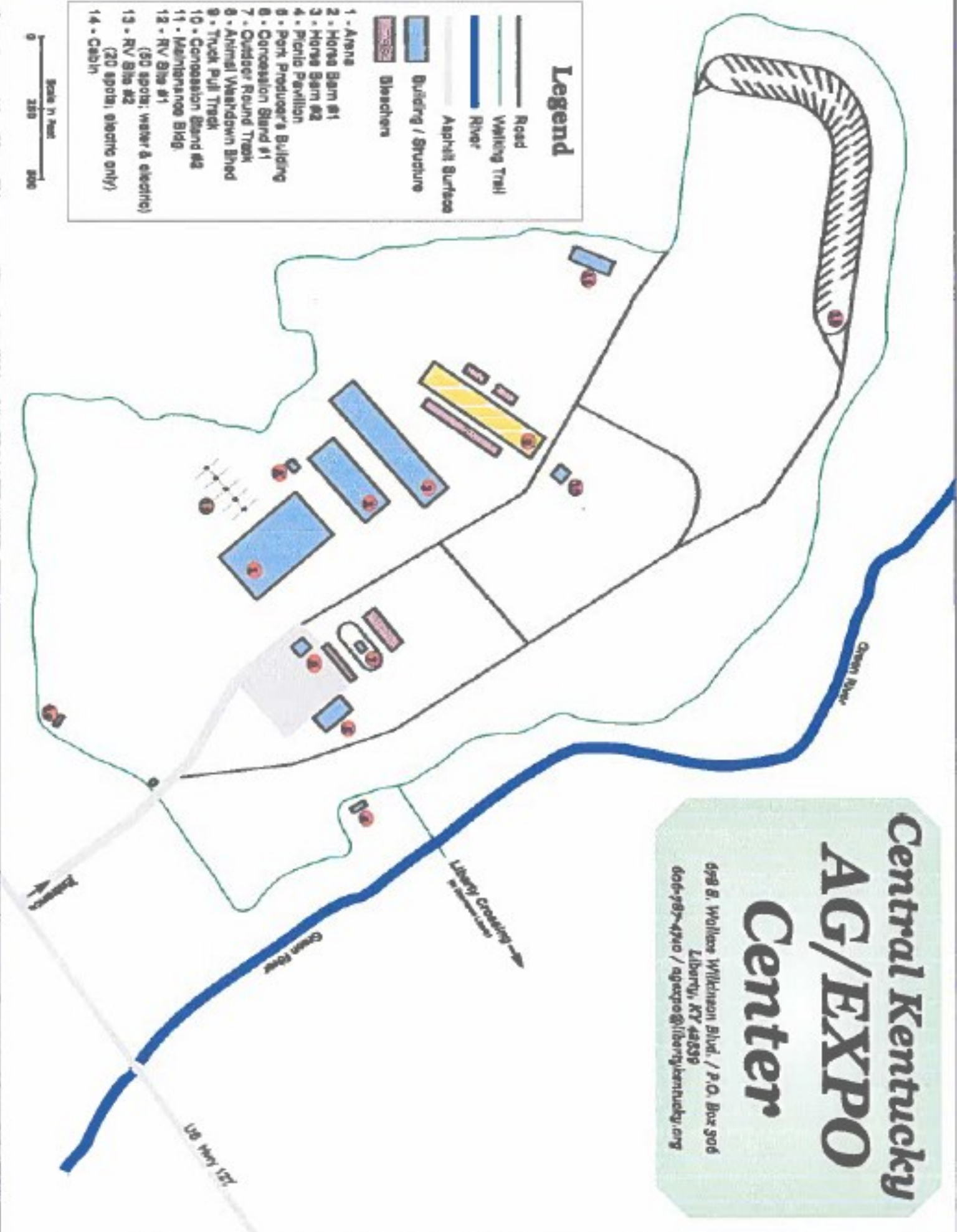
